CIRCULAR

In view of the prevailing weather conditions, Hon'ble the Chief Justice has been pleased to direct that, such number of Gazetted and non-Gazetted staff including contractual staff working on the establishment of this Court be permitted to work from home as may be possible without affecting the smooth working of the Hon'ble Courts. For this purpose, the respective Registrars/OSDs shall prepare roster for the month of December, 2025 on alternate day basis ensuring that at least 50% of the strength of the staff shall daily attend the court in person. Those officers/officials, who are not attending office in person, shall work from home and shall be available on telephone and through electronic means of communications at all times and no such officer/official shall leave the station without taking due permission from this Office.

Further, it is also directed that while making such roster of Gazetted and non-Gazetted staff, preference shall be given to the female staff that are in the family way and to staff members having medical issues, for performing duties from home.

Similarly, all the Principal District and Sessions Judges shall also prepare roster for the month of December, 2025 for the Officers of DHJS, DJS and the staff of the District Courts in Delhi in the aforesaid manner.
