**The Eligibility Criteria for Parties to respond to
Computer Hardware Tender:**


1. The bidders should enclose a copy of Quality Certificate from a recognized institution for their products. The certificate should be either ISO 9001 or equivalent/higher.
2. The bidder's turnover in terms of earnings from sale of computer systems should at least be Rs. 100 crores or above, during the fiscal year 2008-09 & 2009-10 respectively.
3. The bidders should submit documentary evidence and confirmation regarding above along with their tender bids.
4. The bidders should submit an undertaking as follows:

"We (system OEM name) and (bidder's name) also take full responsibility of both Parts & Service SLA as per the content even if there is any defect by our authorized Service Centre/Reseller/SI etc."

5. Bidders must enclose letter of authorization, in case he is not Original Equipment Manufacturer or System Integrator.
6. Preference may be given to Original Equipment Manufacturers.
7. The quantity of computers and other peripherals are likely to vary either on higher or lower sides.

THE TENDER OF ANY VENDOR NOT FULFILLING THE ELIGIBILITY CONDITIONS STIPULATED ABOVE, WILL NOT BE CONSIDERED.
