Terms & conditions of this tender are as under:

- 1) The firm(s) / vendor(s) authorized by OEM intending to participate in the instant tender are requested to submit the necessary Technical/Financial bids along with the copy of current authorization letter of the OEM and Earnest Money Deposit (EMD) worth ₹10,000/- by way of Demand Draft/Bankers Cheque/Pay Order drawn in the favour of "The Registrar General, Delhi High Court" payable at New Delhi.
- 2) Quotations received without EMD shall be summarily rejected and no request for waiver of EMD will be entertained.
- 3) The validity of rates must not be less than 180 days from the last date of submission of quotations. Quotations with less period of validity of rates shall be summarily rejected.
- 4) The successful firm shall be awarded the tender at the quoted/approved rates. In case the firm which has been awarded the tender refuses to supply the required goods at the quoted/approved rates during the validity period of 180 days, the firm shall be liable to be blacklisted for participation in the future tenders of this Court.
- 5) No quotation shall be entertained <u>after due date</u>. Quotations <u>without the subject</u> <u>as referred to above & due date having been mentioned on the envelope</u> shall be summarily rejected. Quotations received after due date shall be summarily rejected.
