**Notes :**

1. The Judicial Officers shall be under the control of the District & Sessions Judge of the District to which they have been allocated.
2. The Judicial Officers under transfer shall pronounce the judgment/orders in the cases in which he/she had reserved judgments/orders before relinquishing the charge of the Court in terms of the postings/transfers order.
3. The new courts of ASJ-05, Central District, Tis Hazari, ASJ-06 and ASJ-07, West District, Tis Hazari, ASJ-06, East District, Karkardooma and ASJ-04, South-West, District, Dwarka are designated as the Courts which shall exclusively deal with cases relating to trial of offences against children, violation of child rights and the cases under the POCSO Act in addition to ASJ-01 in the concerned District.
4. The concerned District & Sessions Judge will ensure that proper track is kept about movement of cases from transferor court(s) to transferee court(s) due to above postings/transfers and no inconvenience is caused to the lawyers and litigants in transfer of cases, which shall be duly notified on the website of District Courts as also outside the transferor court(s).
5. The concerned District & Sessions Judge will assign sufficient number of cases to the newly created courts as above on withdrawal from other such courts of said District ensuring equal distribution.
6. The Courts of ASJ-02 in each District shall be the earmarked Court of their respective jurisdiction for dealing with cases of SEBI Act.
7. The Courts of ASJ-02 in each District is designated as the Special Court for trial of offences under the Drugs & Cosmetics Act, 1940 for their respective Sessions Division.
8. In partial modification of Order No.12/DHC/Gaz/G-1/VI.E.2(a)/2017 dated 15<sup>th</sup> May, 2017, the Court of ASJ-04 in North District, Rohini shall deal with the cases of TADA/POTA/MCOCA since the Court of ASJ-03 in North District, Rohini is a Pilot Court.
9. The Court of ADJ, Shahdara, Karkardooma hitherto being presided over by Mr. Ravinder Singh, DHJS and now allocated to Mr. Sharad Gupta, DHJS is re-designated as ADJ-01, Shahdara, Karkardooma.
10. The Court of ASJ-04, Central, THC hitherto being presided over by Mr. Chandra Shekhar, DHJS and now allocated to Ms. Poonam Chaudhary, DHJS is re-designated as ASJ-02, Central, THC.
11. The Industrial Tribunals and the Labour Courts shall be functional from Dwarka District Court Complex w.e.f. 06.11.2017.


