**NOTICE**

It is notified for information of all concerned that pursuant to the Order dated 17.05.2019 passed in W.P. (C) No. 5271/2019 titled "*Jeevan Singh & Ors. V. Registrar General, High Court of Delhi*", (i) the representations dated 01.04.2019 (received on 03.04.2019) made by some of the petitioners therein with regard to fixation of cut-off date as 05.06.2018 and recalling the syllabus prescribed in the Notice bearing no. 56/Exam./DHC dated 30.03.2019, (ii) other identical representations and (iii) some cross-representations made by other officials of this Court *inter alia* praying that the cut-off date as notified in the said Notice dated 30.03.2019 may not be changed, were placed in the Joint Meeting of the "*Committee for Amendments/Review of Rules of the Appointment, Conditions of Service, etc of the Officials/Employees of Delhi High Court/District Courts*" and "*Committee for Appointment/Selection of Officers of the High Court and District Courts*" held on 28.05.2019.

The Competent Authority, on the recommendations made in the aforesaid Joint Committee, has been pleased to direct that the cut-off date for determining eligibility of applicants-candidates of AOJ/Court Master (Departmental) Examination-2019 as well as Private Secretary (Departmental) Examination-2019 be changed from 01.06.2019/15.05.2019 to 04.06.2018 as the vacancies notified fell vacant prior to 05.06.2018, i.e., the date when Recruitment Rules for the posts of AOJ/Court Master and Private Secretary were amended.


Accordingly, the dates of 07.07.2019 and 21.07.2019 fixed for conducting Paper-I and Paper-II of AOJ/Court Master (Departmental) Examination-2019 as well as the dates of 30.06.2019 fixed for conducting Written Exam and 13.07.2019 & 14.07.2019 for conducting Skill Tests of Private Secretary (Departmental) Examination-2019, stand cancelled. After disposal of the aforesaid W.P.(C) No. 5271/2019, the matter will be placed before the Hon'ble Selection/Appointment Committee for fixation of fresh dates of examinations, etc.
