1. Defendants no. 53 & 67 for service of whom fresh summons were issued on the last date, stand served through email on 09.10.2023
2. Ld. Counsel for defendant no. 58 i.e. Hosting Concepts submits that the order passed by the Hon'ble Court on 24.05.2024 has now been complied with and KYC details have been supplied to Ld. Counsel for the plaintiff.
3. Ld. Counsel for defendant no. 63 also submits that orders of the Hon'ble Court dated 24.05.2024 have been complied with and KYC details have been supplied to Ld. Counsel for the plaintiff. Ld. Counsel further submits that compliance affidavit is in the process of being filed.
4. Ld. Counsel for defendant no. 56 i.e. Indian Overseas Bank seeks some more time to file documents in a sealed cover. Let the same be now filed within three weeks failing which heavy cost shall be imposed.
5. Ld. Counsel for defendant no. 30 Vodafone submits that compliance has been carried out of the Hon'ble Court's order.
