## CM APPL No. 28079/2024

- 1. Present application has been filed on behalf of respondent No.3 for modification of the judgment dated 09<sup>th</sup> August, 2023. The prayer clause of the said application reads as under:
  - "i. Pass a direction to modify the Judgment dated 09.08.2023 to the extent that the rebate applicable on the Petitioner will be as SRO No. 40 dated 28.12.2022;
  - ii. Dispose of pending C.M: Appl. No. 18752 of 2024 in view of the above modification in the judgment dated 09.08.2023.





- iii. Pass any other order as it may deem fit and proper in the circumstances of the present case."
- 2. Learned senior counsel for the non-applicant has no objection to the present application being allowed. Consequently, the application is allowed and paragraph 23(ii)(e) shall now read as under:
  - "e. This assessment shall be treated as a fresh assessment and if the tax is paid by the Petitioner within 30 days from the date of demand, then the Petitioner shall be entitled to a 25% rebate as per the S.R.O. No. 40 dated 28.12.2022."
- 3. The parties are at *ad idem* that the petitioner shall be entitled to 25% rebate in respect of the property tax already paid by the petitioner by way of a cheque for the Assessment Years 2016-2023. Recording the aforesaid consensual understanding, all the pending applications stand disposed of.
