## CORAM: HON'BLE MR. JUSTICE RAJIV SAHAI ENDLAW ORDER 17.11.2017

- 1. Hearing on the need to refer the legal question to a Larger Bench concluded.
- 2. Order reserved.
- 3. On enquiry, it is informed that there is no order for payment of compensation in terms of *Atma Ram Properties (P) Ltd. Vs. Federal Motors Pvt. Ltd.* (2005) 1 SCC 705 while granting stay of the order of eviction in the cases mentioned below.
- 4. The counsels have been heard on the said aspect as well.
- 5. After hearing the counsels, payment of compensation at the rate mentioned against each of the matters in the table herein below, payable with effect from the month next after the month in which the period of six months granted for vacation of the premises expired, till further orders, month by month, in advance for each month, by the 10<sup>th</sup> day of the English calendar month is made condition precedent for continuance of the stay of order of eviction in each of the said petitions. Wherever there are arrears, the arrears till 31<sup>st</sup> December, 2010 be paid on or before 15<sup>th</sup> December, 2017:

- 6. If there is any default, the orders of stay of the order of eviction impugned in the petition shall stand vacated and the respondent / landlord shall become entitled to execute the order of eviction subject to the final outcome of these petition.
- 7. Needless to state that the payments aforesaid are also subject to final outcome of the petitions and repatriable by the respondent / landlord in the event of the petitions succeeding.
