“Whenever records in the custody of superior Court are required by the District Courts, the presiding officer of the concerned court shall send a letter of request to the Head of Office of the Superior Court requesting for production of the records instead of sending summons.”

The format of 'letter of request' is attached herewith.

This Practice Direction shall come into force with immediate effect.
