The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof,

notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.

- 3. The Principal District & Sessions Judge, New Delhi District shall withdraw sufficient number of cases year wise from the existing court of PO, MACT, New Delhi District and shall assign the same to the newly constituted court i.e. PO, MACT-02, New Delhi, PHC and shall ensure that after redistribution, both the courts shall have substantially equal work. The Court of PO, MACT, New Delhi, PHC currently presided over by Sh. Ajay Kumar Jain is re-designated as PO, MACT-01, New Delhi, PHC.
- 4. The Court of Ms. Navita Kumari Bagha, Judge, Family Court-01, South-West, Dwarka stands re-designated as "Additional Principal Judge, Family Court, South-West, Dwarka". The Court of Additional Principal Judge, Family Court, South-West, Dwarka, presided over by Ms. Niyay Bindu, stands re-designated as Judge, Family Court-01, South-West, Dwarka.
- 5. Mr. Sachin Sangwan, Additional Director-II, Delhi Judicial Academy (in Diverted Capacity) will be treated as "on Deputation", whereas Mr. Dheeraj Mittal, Additional Director, Delhi Judicial Academy will be treated as "in Diverted Capacity".
