**HON'BLE MR. JUSTICE AMIT BANSAL**

2. AT 10:30 A.M., FIRST, MENTIONING OF MATTERS BY LD. COUNSELS, PHYSICALLY PRESENT IN THE COURT WILL BE TAKENUP. THEREAFTER, THROUGH VC.
3. SUPPLEMENTARY PASSOVERS WILL BE TAKEN UP AT THE END OF SUPPLEMENTARY LIST.
4. ON THE DAY WHEN PRONOUNCEMENT OF JUDGMENT IS FIXED FOR 10.30. A.M.. MENTIONING OF MATTERS WILL BE TAKENUP AFTER PRONOUNCEMENT OF JUDGMENT.
5. ADVOCATES, REQUIRED PERSONS, PARTIES IN PERSON AND OTHER PARTICIPANTS APPEARING THROUGH VC SHALL KEEP THEIR MICROPHONES MUTED AND CAMERA OFF TILL THEY ARE CALLED UPON TO MAKE SUBMISSIONS.
