- 1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
- 2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
- 3. The Principal District & Sessions Judge, Central shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-02 and 04, Central, THC presently presided over by Mr.Mayank Aggarwal and Ms.Aradhana, respectively and assign the same to the newly created physical JMFC (NI Act) Courts-08 and 09, Central, THC to be presided over by Ms.Surbhi Gupta Anand and Ms.Aradhana, respectively. Further, the Principal District & Sessions Judge, Central shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-01 and 03, Central, THC presently presided over by Ms.Pooja Suhag and Ms.Shubhamjot Kaur Rakhra, respectively and re-distribute the same amongst the physical JMFC (NI Act) Courts and to other Courts of JMFCs of the district so as to ensure equal distribution of work.
- 4. The Principal District & Sessions Judge, West shall withdraw the cases from the existing JMFC (NI Act) Digital Court-02, West, THC presently presided over by Ms.Shivangi Mangla and assign the same to the newly created physical JMFC (NI Act) Court-05, West, THC to be presided over by the said officer. Further, the Principal District & Sessions Judge, West shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-01 and 03 presently presided over by Mr.Abhay Choudhary and Ms.Deshna Golechha, respectively and re-distribute the same amongst the physical JMFC (NI Act) Courts and to other Courts of JMFCs of the district so as to ensure equal distribution of work.
- 5. The Principal District & Sessions Judge, East shall withdraw the cases from the existing JMFC (NI Act) Digital Court-01, East, Karkardooma presently presided over by Mr.Sidhant Krishan Singh and assign the same to the newly created physical JMFC (NI Act) Court-02, East, Karkardooma to be presided over by Ms.Shraddha Tripathi. Consequently, the Court of JMFC (NI Act), East, Karkardooma, presently presided over by Mr.Ankit Solanki, stands re-numbered as JMFC (NI Act)-01, East, Karkardooma.
- 6. The Principal District & Sessions Judge, North-East shall withdraw the cases from the existing JMFC (NI Act) Digital Court, North-East, Karkardooma presently presided over by Mr.Aakash Mohan Singh and assign the same to the newly created physical JMFC (NI Act) Court, North-East, Karkardooma to be presided over by Ms.Nishtha Mehtani.
- 7. The Principal District & Sessions Judge, Shahdara shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-01 and 02, Shahdara, Karkardooma presently presided over by Ms.Nishi Jindal and Mr.Vinod Kumar, respectively and re-distribute

- the same amongst the existing physical JMFC (NI Act) Court and to other Courts of JMFCs of the district so as to ensure equal distribution of work.
- 8. The Principal District & Sessions Judge, North-West shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-01 and 02, North-West, Rohini presently presided over by Ms.Surbhi Sharma and Ms.Shraddha Tripathi and re-distribute the same amongst the existing physical JMFC (NI Act) Court and to other Courts of JMFCs of the district so as to ensure equal distribution of work.
- 9. The Principal District & Sessions Judge, North shall withdraw the cases from the existing JMFC (NI Act) Digital Court-01 presently presided over by Mr.Gaurav Dahiya and assign the same to the newly created physical JMFC (NI Act) Court to be presided over by the said officer. Further, the Principal District & Sessions Judge, North shall withdraw the cases from the existing JMFC (NI Act) Digital Court-02 (presently vacant) and re-distribute the same amongst the other Courts of JMFCs of the district so as to ensure equal distribution of work.
- 10. The Principal District & Sessions Judge, South shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-01, 02 and 03, South, Saket, presently presided over by Ms.Norma Jain, Ms.Pooja Kumari and Ms.Anshul Agnihotri, respectively and assign the same to the newly created physical JMFC (NI Act) Courts-09, 10 and 11, South, Saket to be presided over by Mr.Sidhant Krishan Singh, Ms.Pooja Kumari and Ms.Anshul Agnihotri, respectively. The Principal District & Sessions Judge, South shall also assign the cases of physical NI Act Courts in such a manner that after redistribution, all courts should have substantially equal number of cases.
- 11. The Principal District & Sessions Judge, South-East shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-01, 02 and 03, South-East, Saket presently presided over by Mr.Navdeep Gupta, Mr.Ajay Narwal and Mr.Prithvi Joshi, respectively and assign the same to the newly created physical JMFC (NI Act) Courts-06, 07 and 08, South-East, Saket to be presided over by Mr.Anurag Chhabra, Mr.Mayank Aggarwal and Ms.Surbhi Sharma, respectively. The Principal District & Sessions Judge, South-East shall also assign the cases of physical NI Act Courts in such a manner that after redistribution, all courts should have substantially equal number of cases.
- 12. The Principal District & Sessions Judge, New Delhi shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-01, 02 and 03, New Delhi, PHC presently presided over by Ms.Shivangi Vyas, Mr.Shivam Gupta and Ms.Nishtha Mehtani, respectively and re-distribute the same amongst the existing physical JMFC (NI Act) Courts and to other Courts of JMFCs of the district so as to ensure equal distribution of work.
- 13. The Principal District & Sessions Judge, South-West shall withdraw the cases from the existing JMFC (NI Act) Digital Courts-01, 02, 03, 04, 05, 06, 07, 08, 09, 10, South-West, Dwarka presently presided over by Mr.Shubham Gupta, Ms.Sonica Meena, Mr.Anurag Chhabra, Mr.Kawal Singh, Ms.Surbhi Gupta Anand, Ms.Deepika Yadav, Mr.Anubhav Bijalwan, Ms.Shreya Singh, Ms.Nandini Sharma, Mr.Amit Rana, respectively and re-distribute the same amongst the existing physical JMFC (NI

- Act) Courts and to other Courts of JMFCs of the district so as to ensure equal distribution of work.
- 14. The concerned Judicial Officer(s) shall ensure that no adverse orders are passed on the first date after receipt of the case by way of transfer.
- 15. All Relieving JMFCs/Civil Judges shall perform all judicial works except deciding the cases finally. However, if they are deputed in Evening Court or in a Court, where the officer is on long leave, i.e., beyond one month, in such cases, the Relieving JMFC/Civil Judge are empowered to decide the cases finally. All Principal District and Sessions Judges shall keep record of the work done by the Relieving JMFCs/Civil Judges posted in their respective districts and shall forward the same to the High Court on quarterly basis or till they get regular posting, whichever is earlier.
