As per the provisions of the Real Estate (Regulation & Development) Act, 2016 and the National Capital Territory of Delhi Real Estate (Regulation and Development) (General) Rules, 2016, applications have been sought for one vacant post of Member in the Real Estate Regulatory Authority for NCT of Delhi and UT of Chandigarh. The appointment, service conditions, powers, emoluments even working as well as the removal from the post have been provided in Chapter-V of the Real Estate (Regulation & Development) Act, 2016 as well as Chapter-VI of the Real Estate (Regulation & Development) (General) Rules, 2016. The salary, allowances and other terms and conditions of service of Member shall be governed under the provisions of the Real Estate (Regulation and Development) Act, 2016 and rules framed thereunder.

- 2. As per Section 22 of the Real Estate (Regulation & Development) Act, 2016, the qualifications for the post of Member in the Real Estate Regulatory Authority are as follows:-
 - 2.1 A Member of the Authority shall be appointed from amongst persons having adequate knowledge of and professional experience of at least fifteen years in the case of Member in urban development, housing, real estate development, infrastructure, economics, technical experts from relevant fields, planning, law, commerce, accountancy, industry, management, social service, public affairs or administration.
 - 2.2 Provided further that a person who is, or has been, in the service of the State Government shall not be appointed as a member unless such person has held the post of Secretary to the State Government or any equivalent post in the State Government or Central Government.

As per Section 23 of the said Act, the member of the Real Estate Regulatory Authority for NCT of Delhi and UT of Chandigarh shall hold the office for a term not exceeding five years from the date on which they enter upon their office, or until they attain the age of sixty-five years, whichever is earlier and shall not be eligible for reappointment. Moreover, before appointing any person as a Member, the appropriate

- Government shall satisfy itself that the person does not have any such financial or other interest as is likely to affect prejudicially his functions as such Member.
 - 4. Salary and allowances payable and other terms and conditions of service of the Member of the Authority shall be governed as per provisions of Section 24 read with Rule 18 of the Real Estate (Regulation and Development) Act, 2016.

5. Read the General Instructions Carefully:

- 5.1 All eligible persons/candidates must have fulfilled the minimum eligibility criteria on the date of application. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a person/candidate to be necessarily considered or called for interaction. More stringent criteria may be applied for short-listing the candidates to be called for interaction.
- 5.2 No TA/DA will be admissible, in case, called for interaction before the Selection Committee.
- 5.3 Canvassing in any form shall be a disqualification for the post. No correspondence with the person/candidate will be entertained.
- 5.4 Proforma of application is enclosed below and application must be submitted in typed/printed form. However, the persons/candidates are advised to check the official website of the Land & Building Department of GNCT of Delhi i.e. https://land.delhi.gov.in/ for other related information.
- 5.5 Incomplete applications or application submitted in a different format shall not be accepted/entertained and each applicant should have duly filled up the self declaration as a part of the proforma of application which is mandatory, otherwise the application shall summarily be rejected.
- 5.6 Persons who wish to apply must have essential qualification as per section 22 of the said act before applying for the above said post. Otherwise, application shall be rejected without, any intimation. Further, persons are requested to enclose essential documents which indicate the total work experience of the person.
- 5.7 Applications received after the due date and time shall not be entertained and rejected.
- 6.
