**Notes:-**

1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
2. The judicial officer(s) under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
3. In terms of directions of Hon'ble Supreme Court in WP(C) 900/2020, officers who have been posted as District Judge (Commercial Court) for the first time, shall undergo compulsory training as scheduled by the Delhi Judicial Academy prior to taking charge of their respective courts.
