### PUBLIC NOTICE

Elections for electing 23 Members of Bar Council of Delhi (BCD), a statutory body constituted under the Advocates Act, 1961 are scheduled to be held on 21.02.2026, 22.02.2026 and 23.02.2026 from 09:00 a.m to 05:00 p.m in the premises of High Court of Delhi.

Presently, the electoral roll of voters for the said elections is stated to be around 98,300.

Two areas in Delhi High Court premises are being designated for the polling.

One polling area has been designated in front of main building of Delhi High Court for which entry will be from Gate No. 3 and exit will be from Gate No.4.

The second polling area has been designated in the car parking for which entry will be from Gate No.5 and exit will be from Gate No.7.

207 Polling Booths are being set up in the area between Gates No. 3 & 4 and 280 Polling Booths are being set up between Gates No. 5 & 7 for facilitating casting of votes by the members.

The work of setting up of the above said Polling Booths in Delhi High Court shall commence in the evening of 13<sup>th</sup> February, 2026.

Therefore, **alternative car parking arrangements have been made by Bar Council of Delhi at Major Dhyan Chand National Stadium from 16.02.2026 to 23.02.2026** (copy of letter written by the Chairman, Special Committee, BCD to Delhi High Court and letter written by the Returning

Officer, BCD to the President, Delhi High Court Bar Association are enclosed herewith).

Around 200-300 vehicles shall be allowed to be parked in the stadium with entry from Gate No.2A and exit from Gate No.7 from 16.02.2026 to 20.02.2026.

From 21.02.2026 to 23.02.2026, the entire parking at Major Dhyan Chand National Stadium shall be available for lawyers visiting the Delhi High Court with additional entry and exit from Gate No.5A. Valet parking facility will be made available there.

Shershah Road would be closed for traffic from Purana Quila to India Gate (till the inter-section with Justice Sunanda Bhandare Marg) from 21.02.2026 to 23.02.2026 and parking of vehicles will not be permissible on Shershah Road and on the road adjacent to Gate No. 7 of the High Court.

The parking at 'S' Block will also not be available for lawyers/court staff (except for persons with disability) from 21.02.2026 to 23.02.2026 as the same is to be provided to a large number of employees who will come from different institutions for conducting the poll.

Hence, the lawyers/court staff coming to Delhi High Court are requested to utilize the parking space that has been made available in the National Stadium by BCD and lawyers/court staff are further requested to make optimum utilization of the automated parking at Shershah Road where **automatic cars having neutral gear can also be parked.**

The counting shall commence from 26.02.2026 onwards in the Lobby of Extension Block of High Court of Delhi.

The ballot boxes shall be kept under security in the Lobby of Extension Block. Therefore, the entry to the said Lobby from glass door side (including the lifts there) shall be cordoned off from 16<sup>th</sup> February, 2026 and entry to the Lobby would be only from the side of the canteen.

Co-operation of all the stakeholders is solicited for conducting the elections of BCD smoothly.


The lawyers and litigants may consider appearing through Video Conferencing from 16.02.2026 to 23.02.2026 to minimize the footfall in the premises of High Court of Delhi.

An emergent meeting of the Special Committee and the Election Committee of Bar Council of Delhi was convened at a short notice on 05<sup>th</sup> February 2026 at 4.30 PM at Bar Council of Delhi office, 1-F, Lawyers Chamber, High Court of Delhi, New Delhi and after due deliberations, and keeping in view the suggestions given by your goodself, it has been decided that owing to the India AI Impact Summit Delhi 2026 at Bharat Mandapam from 16<sup>th</sup> to 20<sup>th</sup> February, 2026, being inaugurated by Hon'ble Prime Minister of India, and to be attended by international delegates from all over the world including 15 head of nations, the pressure on infrastructure including manpower, security would warrant that the election scheduled be relooked, since more than 4,000 traffic personnel would be deployed to facilitate regulation and ease of traffic and in addition thereof, the deployment of security personnel of paramilitary forces is also on an extremely large scale and that being so, most of the traffic of India AI Impact Summit Delhi 2026 will be flowing through Mathura Road and India Gate

Dear Sir,

I would like to inform your good self that in view of the election of the Bar Council of Delhi, scheduled to be held from 21st to 23rd February, 2026, alternative adequate parking arrangements have been made at Major Dhyan Chand National Stadium. On 16<sup>th</sup> to 20<sup>th</sup> around 200-300 vehicle shall be allowed from Gate No.2A and w.e.f. 21<sup>st</sup>, 22<sup>nd</sup> 23<sup>rd</sup> February, entire parking shall be available for the lawyers visiting the Delhi High Court.

Further, considering the large voter turnout anticipated on the polling days (21<sup>st</sup> to 23<sup>rd</sup> February), I would request your goodself to provide some subordinate staff for election related duties, and further attendants to be earmarked and deployed at appropriate locations for smooth coordination of arrival and departure of voters' vehicles.

Further-more, we would also require the wheelchairs available with your office, along with necessary handlers, to facilitate voters who may need assistance.

You are, therefore, requested to kindly provide the services of the subordinate staff (except administrative staff) and attendant staff as well as approximately ten (10) wheelchairs along with handlers, on all the three days mentioned above.
