**Note(s):**

- (i) The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
- (ii) The judicial officer(s) under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.

- (iii) The Ld. Principal District & Sessions Judge, South shall withdraw sufficient number of regular suits pending in the court of Sr. Civil Judge, CCJ-ARC-ACJ, JSCC-ASCJ-Guardianship Judge and CJ-01 and shall assign the same to the Court of Mr. Yashdeep Chahal, CJ-02, South, so as to ensure equal pendency of cases.
- (iv) The Court of Ms. Vidushi Garg, JMFC (Digital Traffic Court), New Delhi District, PHC shall stand re-designated as Digital Traffic Court-01.
- (v) The Ld. Principal District & Sessions Judge, New Delhi shall withdraw sufficient number of cases from the Court of Digital Traffic Court of Ms. Vidushi Garg and assign them to newly created Digital Traffic Court-02 so as to ensure equal distribution of work.
- (vi) The Court of Ms. Sanya Singh JMFC-06, East, KKD shall stand re-designated as JMFC-07.
- (vii) The cases of PS Pandav Nagar pending in the Court of Ms. Prigya Gupta, CJM, East, KKD and cases of PS Gazipur pending in the Court of Mr. Sachin, JMFC-03 East, KKD shall be withdrawn and assigned to the newly created Court of JMFC-06. Henceforth, fresh cases pertaining to PS Pandav Nagar and PS Gazipur shall be filed in the newly created of JMFC-06, East, KKD.
- (viii) The cases of PS Shakarpur pending in the Court of JMFC-05, East shall stand withdrawn and transferred to the Court of ACJM, East, KKD.
- (ix) The cases of PS Gokulpuri pending in the Court of JMFC-03, North-East District shall stand withdrawn and shall stand transferred to the Court of JMFC-04, North-East District, KKD. Henceforth, fresh cases pertaining to PS Gokul Puri be filed in the Court of JMFC-04, North-East, KKD.
- (x) The cases of PS Nand Nagri pending in the Court of JMFC-03, Shahdara shall stand withdrawn and transferred to the newly created Court of JMFC-09, Shahdara. Additionally, Ld. PD&SJ, Shahdara shall withdraw 300 cases under Section 138 NI Act from the Court of JMFC-07 Shahdara and 500 cases from the Court of JMFC-08 Shahdara and assign them to the newly created Court of JMFC-09 Shahdara. Henceforth, fresh cases pertaining to PS Nand Nagri be filed in the newly created Court of JMFC-09, Shahdara.
- (xi) The Ld. Principal District & Sessions Judge, Shahdara shall withdraw 400 cases under Section 138 NI Act pending in the Court of JMFC-01, Shahdara and 400 cases under Section 138 NI Act pending in the Court of JMFC-04, Shahdara and transfer them to the Court of JMFC-03, Shahdara.

- (xii) The cases of PS Shahdara pending in the Court of CJM, Shahdara shall stand withdrawn from the said Court and shall stand transferred to the Court of ACJM, Shahdara. Henceforth, fresh cases pertaining to PS Shahdara be filed in Court of ACJM Shahdara.


