The Investors of CRB Capital Markets Ltd. are informed that the Reconstituted Disbursement Committee for disbursement of claims pertaining to CRB Capital Markets Ltd. reconstituted by the Hon'ble High Court vide its order dated 10/4/2024 is still functioning. The Disbursement Committee has processed the files and has intimated to the Depositors by Registered Post. However, some of them have been received back unserved with the reports – 'Left', 'unclaimed', 'incomplete address' etc. Payments made through NEFT / RTGS have also been returned with the remarks – 'Account Closed', 'Incorrect Account number', 'Invalid IFSC Code' etc. The Banks of which account numbers were given by the depositors have been closed / merged with other Banks and the depositors have not furnished their fresh Bank account details. Due to all these deficiencies, the Disbursement Committee is unable to make payments to the depositors.
