AUCTION NOTICE

A large number of obsolete/unserviceable articles of office furniture/furnishing such as Steel Almirahs, Tables, Bicycles, Water Dispensers, Air purifiers, Revolving Chairs, Steel Trolleys etc. and one official Mahindra (Gusto-125) scooter, manufacturing December 2016 and Registration January 2017 (list attached) are proposed to be put to public auction scheduled to be held on **25/07/2026 at 11.30 AM**, at Administrative Block, Ground Floor, Delhi High Court Building at Sher Shah Road, New Delhi on "**AS IS WHERE IS BASIS**" against cash payment of full amount on the spot and picking up of the articles within in one week subject to the approval by Hon'ble the Chief Justice. However, the possession of the scooter shall be handed over only after the deposit of copy of the Registration Certificate in the name of the successful bidder. Insurance of the scooter has expired in the month of May 2026. It shall be the responsibility of the successful bidder to get the RC changed in his/her name at its own cost in coordination with this Court. In case latest Insurance and PUC are required by the transport authority the successful bidder will bear the cost thereof.

The goods shall be auctioned in one lot. The reserve price of the whole lot has been fixed at Rs. 75,000/- by the competent authority. The right to accept or reject, whatsoever, all or any of the bids (highest may be) without assigning any reason, is reserved with this Court.
