Note(s) :

(i) The Judicial Officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.

(ii) The Court of ASJ-03, New Delhi (Presided over by Sh. Prashant Sharma), Court of ASJ-02, New Delhi (Presided over by Sh. Amit Bansal) and the court of Special Judge, NDPS, New Delhi (Presided over by Sh. Jitender Pratap Singh) shall stand abolished.

(iii) POCSO courts of New Delhi Districts which are currently working from RACC shall be shifted back to PHC, New Delhi and shall henceforth start functioning from Patiala House Courts.

(iv) Cases under NIA Act, 2008 investigated by National Investigating Agency (NIA) as well as other connected cases which are at present being tried by PD&SJ, NDD, PHC and ASJ-03, NDD, PHC shall stand transferred to the new NIA courts i.e. SEC-01 to SEC-03, RACC in equal proportion. Remaining cases in the court of ASJ-03, NDD, PHC, New Delhi, if any, be assigned to other Sessions Courts by PDJ, NDD, PHC, New Delhi.

(v) The cases under UAPA (Scheduled Offences under NIA Act) investigated by State Agencies as well as other connected cases which are being tried at present by ASJ-02, NDD, PHC, New Delhi shall stand transferred to the courts of SEC-04 & SEC-05 at RACC in equal proportion. All cases of other Scheduled Offences (other than UAPA) under NIA Act investigated by State Agencies pending in the court of ASJ-02, NDD, PHC, New Delhi shall stand transferred to SEC-06. Remaining cases in the court of ASJ-02, NDD, PHC, New Delhi, if any, be assigned to other Sessions Courts by PDJ, NDD, PHC, New Delhi.

(vi) The cases under NDPS Act pending in the court of Special Judge, NDPS, New Delhi which are investigated by Central Agencies viz., NCB, CNB shall be assigned by PDJ, New Delhi District to SEC-07 & SEC-08 and the cases investigated by other Agencies shall be assigned to SEC-09 & SEC-10. SEC-07, 08, 09 & 10 at RACC shall be under the Administrative Control of PD&SJ, NDD, PHC, New Delhi. It is clarified that the cases of small quantity under NDPS Act and other miscellaneous work pertaining to these courts shall continue to be tried/conducted at PHC, New Delhi.

(vii) All the cases under MCOCA Act as well as other connected cases presently being tried by different Sessions Courts of all districts of Delhi shall stand transferred and assigned by the Ld. PDJ, RACC to the newly created courts of SEC-11 to SEC-13 at RACC while ensuring equal distribution.

(viii) The judicial officer(s) under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.

(ix) Principal District Judges of all districts shall withdraw all other cases from NDPS courts which shall henceforth deal exclusively with NDPS cases only. Such other cases, if pending in NDPS courts shall be assigned to other Session Courts in their respective district while ensuring equal distribution of work.

(x) The court of ASJ-02-cum-Special Judge (NDPS), North-West, Rohini is re-designated as court of Special Judge, NDPS. The courts of Mr. Muneesh Garg, ASJ-03, North-West, Rohini and court of Mr. Sachin Mittal, ASJ-05, North-West, Rohini shall stand re-numbered as ASJ-02 and ASJ-03 respectively. Principal District Judge, North-West, Rohini shall distribute all other cases (except NDPS cases) to the courts of ASJ-02 and ASJ-03.

(xi) The court of ASJ-02-cum-Special Judge, NDPS, East is re-designated as the court of Special Judge, NDPS, East. Principal District Judge, East shall distribute all other cases (except NDPS cases) to the other Sessions courts. The courts of ASJ-03, ASJ-04, ASJ-05 & ASJ-07 shall stand re-numbered as the court of ASJ-02 to ASJ-05 respectively. Ld. PDJ, East shall assign cases to the newly created court of ASJ-07 after withdrawing sufficient number of cases from the other Session Courts ensuring equal pendency.

(xii) The court of ASJ-04+Special Judge, NDPS, South-East is re-designated as the court of Special Judge, NDPS. The courts of ASJ-05 & ASJ-07 of South-East shall stand re-numbered as the courts of ASJ-04 & ASJ-05 respectively. Principal District Judge, South-East, Saket shall distribute all other cases (except NDPS cases) to the other Sessions courts.

(xiii) It is clarified that cases under PMLA pending before ASJ-02 and ASJ-03, New Delhi District, Patiala House Courts, which are arising out of predicate offences under Scheduled Acts under NIA Act shall also be transferred to SE Courts at RACC.

(xiv) All Entrance Examination Fraud Cases pending in any other court at RACC shall be withdrawn by PDJ, RACC and assigned to the court of Special Judge (PC Act)-25.

(xv) The court of District Judge (Commercial Court)-03, Central, THC presided over by Mr. Devendra Kumar Sharma, DHJS stands abolished. Ld. PDJ (Central) shall transfer cases pending in this court to the other courts of District Judge (Commercial), Central District while ensuring equal pendency in all courts.

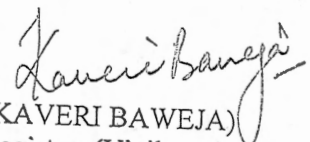
