Note(s):

- (i) The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
- (ii) The judicial officer(s) under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
- (iii) All Relieving JMFCs/Civil Judges shall perform all judicial works except deciding the cases finally. However, if they are deputed in Evening/Weekend Court or in a Court, where the officer is on long leave, i.e., beyond one month, in such cases, the Relieving JMFC/Civil Judge are empowered to decide the cases finally. All Principal District and Sessions Judges shall keep record of the work done by the Relieving JMFCs/Civil Judges posted in their respective districts and shall forward the same to the High Court on quarterly basis or till they get regular posting, whichever is earlier.

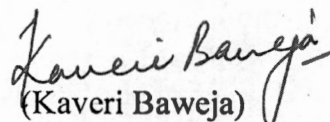
