CIRCULAR

Hon'ble the Chief Justice has been pleased to direct that all the pending Execution Petitions under Section 36 of the Arbitration and Conciliation Act, 1996, shall be listed before the Joint Registrars (Judicial) for verifying whether requisite stamp duty on the arbitral award has been duly paid and where the awards are unstamped or are insufficiently stamped, to take steps as per law.

Similar exercise shall also be carried out by all the District Courts in Execution Petitions under Section 36 of the Arbitration and Conciliation Act, 1996.

In fresh cases, besides making a declaration in bold capital letters at the top of the index stating that the requisite stamp duty on the arbitral award has been duly paid, proof thereof shall also be enclosed.

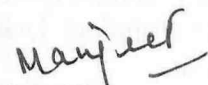
