OF 1 KVA CUSTOMIZED UPS OF REPUTED MAKE WITH TWO (02) INBUILT SEALED MAINTENANCE FREE DRY BATTERIES OF MINIMUM GUARANTEED 15-30 MINUTES BACKUP WHILE USING DESKTOP COMPUTER OR ALL-ONE-PC OR MAC COMPUTER HAVING ATLEAST ONE 16AMP INBUILT/CUSTOMIZED FIVE PIN SOCKET AND THREE 6AMP 3/5 PIN OUTPUT SOCKETS WITH TWO (02) YEARS ONSITE COMPREHENSIVE WARRANTY ON UPS & ONE (01) YEAR ONSITE WARRANTY ON BATTERIES UNDER TWO PACKET SYSTEM I.E. TECHNICAL BID & FINANCIAL BID

The below mentioned ATC will prevail over GeM GTC.

Note: Bidders participating in the Tender must mandatorily comply with the Buyer Added Bid Specific ATC.

Note: Interested firms/vendors based in Delhi/NCR region may visit the IT Store of this Court during the bid duration from 10:00 AM to 04:00 PM to understand the requirement of customized UPS of this Court. For ease of reference the photograph of in built output sockets required in the UPS is at placed at Annexure-‘F’ for reference purpose only.

INVITATION:- Bid(s) are invited by Delhi High Court from the firms/vendors based in Delhi/NCR Region only for procurement of two hundred (200) nos. of 01 (one) KVA UPS of reputed make with 2 inbuilt sealed maintenance free dry batteries of 15-30 minutes guaranteed backup while using Desktop Computer or All-in-PC or Mac Computer having atleast one 16 AMP inbuilt/customized 5 pin output socket and three 6Amp 3/5 pin output socket with 2 years onsite comprehensive warranty on ups & 1 year onsite warranty on batteries.

1. NECESSARY DOCUMENTS TO BE UPLOADED AT THE GEM PORTAL, NON COMPLIANCE WILL LEAD TO REJECTION OF THE BID

- a) Scanned copy of current authorization letter of the OEM of UPS with date of issuance.
- b) Scanned copy of Certificate of incorporation of the Company with Registrar of Companies of Delhi/NCR and/or with date of issuance.

- c) Scanned copy of valid GST Registration Certificate/ TIN No of Delhi/ NCR to prove that the firm is carrying out its business in Delhi/NCR with date of Registration.
- d) Scanned copy of PAN Card of Bidders Company/Proprietorship firms etc.
- e) Scanned copy of **Annexure-‘A’** i.e. ‘Undertaking’ strictly in the format provided. (*duly signed and stamped with the seal of the firm*)
- f) Scanned copy of Earnest Money Deposit (EMD)/Bid security for an amount of Rs.27,750/- by way of DD/ Banker’s Cheque/Pay Order drawn in favour of ‘The Registrar General, High Court of Delhi, New Delhi’ by the bidder(s) who are not exempted to submit EMD as per status of their firms/GeM Guidelines. The physical copy of EMD must be submitted in IT Branch of this Court within 3 days after the bid end date.
- g) Properly filled **Annexure “B”**, Checklist of the required documents strictly in the format provided (duly signed & stamped).
- h) Technical compliance sheet (specification) of the required UPS strictly as per **Annexure-‘C’** (*duly signed and stamped*).
- i) Turnover Certificate issued by a Chartered Accountant in favour of participating bidder showing turnover not less than ₹4 Lakh each for the financial years 2023-2024, 2024-2025 & 2025-26. MSE/Startup vendors need not upload the same but mention the category in the compliance column.
- j) Turnover Certificate of OEM not less than ₹37 lakh issued by any CA (Chartered Accountant) or available on the website of OEM for the year last available.
- k) Three copies of Contracts/CRACs/supply orders issued in favour of the bidder to prove the experience in supply of UPSs to Central / State Government / Public Sector Undertaking / Autonomous Bodies. MSE/Startup vendors need not upload the same.
- l) Scanned copy of valid MSE/UDYAM certificate (as the case may be) with date of issuance.
- m) Scanned copy of valid Certificate of Recognition as Startup firm (as the case may be) with date of issuance.
- n) **Annexure-‘D’** i.e. strictly as per the format of Bid Security Declaration from bidders in lieu of EMD along with supporting valid documents to avail EMD Exemption.
- o) **Annexure-‘E’** Lowest price Certificate strictly as per the format provided.
- p) Escalation Matrix of Bidder’s firm/OEM.

2. **GENERAL INSTRUCTIONS**

- a) This Court shall have the right to call clarification(s) on Gem Portal in respect of the Bid(s), if required.
- b) In case the Contract awarded to L-1 firm is cancelled due to non-acceptance of the same within the stipulated period, the firm shall be liable to be blacklisted to participate in future tenders of this Court and the EMD shall be forfeited without giving any notice. MSE/Startups firms shall be blacklisted for non compliance of this clause.
- c) Rates offered in the Bid shall not be enhanced during the validity of bid i.e 180 days.
- d) The firm/ vendor shall indemnify the High Court of Delhi for any kind of loss due to material mishandling or damage etc.
- e) Addendum/Corrigendum/notice etc. if any shall be uploaded on the GeM Portal only.
- f) This Court reserves the right to relax/waive or alter any of the terms & conditions of this ATC at any stage if it finds sufficient reasons to do so.

- g) Bid Security/EMD of the Bidder(s) will be forfeited, if the bidder(s) amends its quotation, impairs or derogates from the tender, fails to accept the purchase order. MSE/Startups not complying this clause shall also be blacklisted to participate in future tenders of this Court.
- h) The MSE/Startups shall be given relaxation in respect of submission of EMD, years of experience & turnover criteria as per extent GeM guidelines, after submission of supporting documents.
- i) After completion of tender formalities with the successful bidder, the Bid Security/ EMD of the bidders who do not qualify in the instant tender process will be returned, without interest, only on receipt of their written request. It shall be the duty of the bidder(s) to reach out to the IT Branch of this Court with authority letter on letter head of the firm and collect the original Bid Security / EMD instrument against the receipt, after completion of Tender process. In case of delay in collecting the Bid Security/ EMD, Delhi High Court shall not be responsible to pay any kind of interest or penalty.
- j) Technical bid of only those bidders, who have submitted the EMD in original in IT Branch of this Court (except those who are exempted i.e. MSE/Startups having valid supporting document) and uploaded all the required documents including scanned copy of EMD within the prescribed time period, will be technically evaluated. In case of any clarification is required or deficiency(ies) found in the Technical bid, the firm will be given an opportunity to remove the deficiencies pointed out or submit the response to clarification sought. However failure to remove the deficiency or addressing the clarification sought, the Technical Bid of the vendor shall be rejected and the financial bid of the vendor will not be opened.
- k) The bids or subsequent representation/queries/challenge to rejection of technical bid shall be submitted strictly as per the prescribed procedure only on GeM portal during the window open for such action. Any communication, representation or challenge to technical rejection submitted by telegram/fax/e-mail/Speed Post/Courier/physically delivery of letter, etc. i.e. outside of GeM shall not be considered. No correspondence will be entertained in this regard.
- l) The selected bidder shall be required to nominate one Technician/Representative/SPOC (Single Point of Contact) of their firm for installation of UPSs whenever required and address the request(s) made by this Court regarding after sale support/technical support within the comprehensive warranty (ies) period with the coordination of OEM of UPS.
- m) After issuance of contract at GeM Portal, the successful Firm(s)/Bidder (s) at the first instance shall **provide one UPS offered by them against their bid for testing purposes immediately in the IT Store of this Court, if any deficiency/defect is found, an opportunity will be given to remove the deficiency or defect within 07 (seven) days and only after satisfaction of this Court expressed in writing, the firm can proceed to supply the whole lot in the IT Store of this Court, situated in the Basement of Lawyers' Chambers Block-III, High Court of Delhi, New Delhi-110003, at no extra charge.**
- n) In case of any fault is found in UPS(s) or in its part(s), thereof, the vendor shall be required to remove the faulty UPS(s)/part(s) thereof from the Court premises & get it replaced/repaired and return the same to IT Store of this Court at his/her own expenses during the onsite comprehensive warranty period.

3. OPENING OF FINANCIAL BID

- a) After evaluation of the Technical Bid(s), its acceptance/rejection, addressing challenge/representation within the window opened for the same, the Financial Bid(s) of shortlisted bidders will be opened on GeM Portal & put to Reverse Auction as per procedure. If the date of opening of Financial Bids falls on holiday being observed by Delhi High Court, the financial bids will be opened on the next working day.

4. FINANCIAL BID

- a) Total Rates shall be quoted for supply of 200 required UPSs in Indian Rupees which shall include supply, transportation, onsite unboxing, testing and operational demonstration. No exemption will be provided for correction in the financial bid. Moreover, in case of conflict in amount mentioned in numbers and words, the amount mentioned in words will prevail.
- b) The request made by 'successful bidder' for variation in rates due to fluctuation in the foreign exchange rate or escalation or other factors shall not be considered except change in the rate of GST by the Central and State Government.
- c) Any change in the rate of GST during the Contract shall be communicated by the supplier to IT Branch of this Court immediately with documentary proof i.e. Notification issued by Central/State Government to this effect.

5. GROUNDS FOR REJECTION/DISQUALIFICATION OF BID(S)

- a) Non submission of original EMD/ Bid security instrument to IT Branch of this Court within the stipulated period as indicated at point 1(f) at prepage (except those who claim to be exempted).
- b) If multiple quotations are submitted by a firm / vendor which is proved by the IP addresses provided at the GeM Portal, all such quotations submitted will be liable to be rejected and an instance shall be raised on GeM Portal.
- c) Validity of rates must not be less than 180 days from the last date of submission of the Bid.
- d) Bids related to some other item or product not related to instant tender.
- e) Non-uploading of required documents or uploading of incomplete documents in terms of the documents required at Point (1) at prepage and checklist strictly as per **Annexure-'B'**
- f) Any other ambiguity in submission of bid or failure to address clarification sought or to submit deficient documents at GeM Portal during the clarification window remain active resulting in vitiating the whole tender process.
- g) Conditional Bids(s).
- h) Having the office of bidder not registered in Delhi/NCR Region as per documents required at Point 1 above.

6. THE FIRM(S)/VENDOR(S) MAY BE BLACKLISTED FOR THE FOLLOWING REASONS:

- a) Withdrawal or attempt to revise the technical/financial bid on any ground after opening of the same.
- b) Non acceptance of the Contract.
- c) Non adherence to the validity of rates for 180 days from the last date of submission of tender for the product being offered and required by this Court.

7. FINALITY OF DECISION OF THE COMPETENT AUTHORITY

- a) The decision of the competent authority for short listing of the bidders after evaluation of the Technical Bid(s) shall be final & binding on all the participants in the instant tender process.
- b) This Court reserves the right to modify/amend the tender document/Terms and Conditions of the tender at a later stage and also to increase or decrease the quantity of UPS upto 25% depending on the requirement and also cancel the 'Tender' without assigning any reason(s) thereof.
- c) This Court also reserves the right to reject any of the bids or all the bids or quash the whole tender process without assigning any reasons thereof. Any step taken by the competent authority to safeguard the interest of this Court shall be final and binding on all participants.

8. RATES, TAXES & PAYMENT

- a) The total value of 200 nos. of UPS inclusive of all (which shall include supply, transportation, onsite unboxing, testing and operational demonstration) shall be filled in the financial bid.
- b) No enhancement of rates shall be permitted during the contract period.
- c) The bill/invoice in triplicate towards supply of 200 nos. required/offered UPSs shall be submitted in the name of Registrar General, Delhi High Court, New Delhi-110503 in IT Branch of this Court situated at Lawyers Chamber, Block-III, Room No.-6, Delhi High Court.
- d) There shall not be any advance/partial payment or any extra charge shall be payable by this Court in any case.

Note: No employee of this Court or his/her dependent family members be involved in the instant tender process in contravention of the requirement/provision contained in Central Civil Services (Conduct) Rules, 1964.

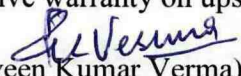
