ORDER

In view of insertion of Section 12A in the Public Examinations (Prevention of Unfair Means) Act, 2024 by way of the Public Examinations (Prevention of Unfair Means) Amendment Act, 2026 and in continuation of Order No. 29/D-3/Gaz.1A/DHC/2026 dated 23.07.2026 and Order No. 32/D-3/Gaz.1A/DHC/2026 dated 01.08.2026 of this Court, Hon'ble the Chief Justice has been pleased to direct that all miscellaneous proceedings/inquiries/trials pending before any Court in Delhi involving provisions of the Public Examinations (Prevention of Unfair Means) Act, 2024, shall stand withdrawn and transferred to the Court of Special Judge (PC Act)(CBI)-25, (Specially Designated Fast Track Court), RACC, New Delhi with immediate effect.

Further, all fresh FIRs registered under the said Act and the proceedings emanating therefrom shall henceforth be dealt with by the aforesaid Fast Track Court at RACC, New Delhi.
