2. In case first link officer is not available then only the charge will be assigned to second link Officer, as indicated above. In case both the Link Officers are not available, the concerned DRAT may refer the matter to this Department for obtaining the approval of the Competent Authority for assigning additional charge in the matter.

3. Hon'ble Chairpersons of DRATs are also requested to put into place the similar Link Officer System in respect of Presiding Officers to ensure uninterrupted smooth functioning of DRTs during the leave or absence of any Presiding Officer of DRT under their respective jurisdiction. A copy of such order issued by each DRAT may be furnished to this Department for records.
