No. 109) dated 11th August, 2006, amended vide Notification No.117/Rules/DHC dated 8.5.2007 published in Delhi Gazette Extraordinary Part IV No. 80 (N.C.T.D. No. 30) dated 8.5.2007, further amended vide Notification No.225/Rules/DHC dated 29.10.2007 published in Delhi Gazette Extraordinary Part IV No. 185 (N.C.T.D. AMENDMENTS

- I. The Explanation shown before Rule 3(a) shall be read at the end of Rule 3.
- II. In the existing Rule 3(a), the words "in favour of the Registrar General, High Court of Delhi by way of cash, Indian Postal Order, Demand Draft, Pay Order" shall Be added after the words "application fee" and before the words "as per Rule 10 with the authorized person".
- III. The following proviso shall be added immediately after the existing Rule 3(a), in The following manner :-

"Provided that no application shall be rejected only on the ground that it is not in Form A."
- IV. Sub-rule (i) of Rule 4 stands deleted.
- V. Sub-rules (b) and (c) of Rule 5 stand deleted.
- VI. The following shall be substituted for the existing Rule 6 :-

"6. Information which is to be furnished and access to records shall be subject to the rules/regulations pertaining to destruction of records in force from time to time which may have been notified or implemented by this Court."
