

**STANDARD OPERATING PROCEDURE (SOP) FOR RESUMPTION OF
PHYSICAL FUNCTIONING IN THE HIGH COURT OF DELHI W.E.F. 01.09.2020**

Pursuant to the directions contained in the Standard Operating Procedure (SOP) approved by this Court, the entry time to the court blocks for attending physical hearing shall be regulated as per the time slots for different batches of cases. Each batch shall consist of 10 cases. Entry of the first batch to the particular floor of the court block shall take place at 10.00 am. Second batch shall be permitted entry to a designated waiting space inside the court block at 11.15 am and the third batch at 12.15 pm.
